



The Joint Declaration on the Doctrine of Justification which is considered to be 'a milestone on the journey of ecumenism' has a very significant place in the theological-ecumenical realm since it hoped to overcome the disunity between the protestant Churches and the Catholic Church at large. This work analyzes and redefines the JDDJ from a Pentecostal perspective, and proposes a new Pentecostal view of ecumenism for this century. The major questions that are considered here are: what is the ecumenical and ecclesiastical significance of this Joint Declaration in the 21st century, what are the neglected theological elements in the Joint Declaration, what are the controversial issues connected to the JDDJ and what challenge can it give to the present world of Christianity? The JDDJ has become a basis for theological agreement and further discussions. This study also brings out ecumenical and theological understandings of the Pentecostal Church and substantiates the Pentecostal assessment of the JDDJ. The first chapter has two parts: the first part explains the research topic, methodology and the importance of the research; and the second part gives an outline of the Pentecostal movement and its theology mainly with regard to the doctrine of justification. The second chapter deals primarily with the significant stages and influences that helped for the formation of JDDJ. The last part of this chapter explains the responses of other churches to the JDDJ. The third chapter presents a Pentecostal response to the JDDJ, which starts with a positive evaluation and will be followed by a negative response to the same. The fourth chapter expounds the development of a paradigm model for the ecumenical thinking of the 21st century from a Pentecostal point of view. The Proposed slogan for this century can be "back to Pentecost" and be united in the love and power of the Holy Spirit. Because it is said that Pentecostal experience of the 1st-century Christianity has had a true Ecumenism, which was somehow lost in the long

run. Nevertheless, methodological shifts in the approach to ecumenism can still make a change. When such a step is taken, the good news of unity of Christians will become a reality. Only then one can say that the condemnation of the 16th century regarding the doctrine of justification is invalid.



Depuis le vingtième siècle, la réflexion sur la théologie trinitaire s'est renouvelée. Bien que de nombreux théologiens aient contribué à ce renouveau, un crédit peut en être attribué à K. Rahner, qui a ouvert de nouvelles perspectives approfondies en proposant une nouvelle théologie trinitaire basée sur le « Grundaxiom ». tit au paradigme transcendental de K. Rahner, dont il discute objectivement les critiques. À base d'une description diachronique et synchrone, de diverses contributions progressives d'innombrables théologiens, dans leurs dialogues avec K. Rahner, mais surtout influencés par son « Grundaxiom », l'auteur épouse également le dialogue comme mode opératoire fondamental pour faire avancer et construire la théologie trinitaire. Le livre contient aussi une représentation graphique et est bien organisé en tant qu'outil pédagogique. Il présente un grand intérêt pour le monde tant religieux qu'académique, chercheurs, étudiants et professeurs, mais également pour tous ceux qui cherchent à approfondir leur compréhension de ce plus grand mystère de la foi chrétienne : la Trinité.





This book is about the Russian contribution to monasticism on Mount Athos and the Athonite contribution to Russian spirituality and marks the millennium of the Russian presence on Mount Athos. Athos has been the spiritual heart of the Orthodox world for even longer and Russian pilgrims have congregated there throughout its history. Russian monks visiting Athos have returned to their homeland with the treasures of Athonite spirituality such as

the practice of hesychasm in the sixteenth century, the Patristic anthology known as the *Philokalia* in the eighteenth century, and the spiritual classic *The Way of a Pilgrim* in the nineteenth century. In the twentieth century the Russian monastic population fluctuated wildly, but still they produced influential elders such as St Silouan and Fr Sophrony, and Athonite elders continue to exercise enormous influence on the revived Russian Orthodox Church to this day. The papers collected in this volume, first delivered as contributions to a conference held by the Friends of Mount Athos in February 2017 at Madingley Hall, Cambridge, span the breadth of the millennium.

**NICHOLAS FENNELL** is a graduate of Trinity College, Cambridge, where he was a Senior Scholar. He taught at Winchester College for forty years before devoting himself to research into the Russian presence on Athos, and into Greek-Russian ecclesiastical relations. His publications, in Russian and English, include *The Russians on Athos* (2001) and *Il'insky skit na Afone* (2011).

**GRAHAM SPEAKE** is a writer and publisher with degrees in classics from Cambridge and Oxford. He is founder and Chairman of the Friends of Mount Athos and a Fellow of the Society of Antiquaries. He is author of *Mount Athos: Renewal in Paradise* (2nd edn. 2014), which won the 2002 Criticos Prize, and of *A History of the Athonite Commonwealth: The Spiritual and Cultural Diaspora of Mount Athos* (2018).



This book analyses early Christian texts on prayer. These texts provide a rich perspective on the formation of Christian identity in the early church. The primary sources investigated are the four earliest known treatises on prayer in Christian history, written by Clement, Origen, Tertullian and Cyprian in the beginning of the third century. Prayer and identity have both individual and collective expressions, and theological treatises reveal an interplay between these phenomena. The book examines the relational character of Christian prayer: how prayer establishes a relationship between the individual and God; how other social relations are reinforced by prayer in direct and indirect ways; and how individual Christians are connected to their own self in prayer.

*Origins of Eastern Christian Mysticism* asserts that the thinkers between Basil of Caesarea and Symeon the New Theologian were important mainly for their role in the formation of Hesychasm, a fourteenth-century mystical movement in the Eastern church. The book surveys previous research on Proto-Hesychasm and sets forth eight Hesychastic trends in its practitioners: monasticism, dark and light mysticism, and an emphasis on the heart, *theōsis*, the humanity of Christ, *penthos*, and unceasing prayer. Theodore Sabo integrates detailed and carefully researched accounts of the lives and thought of the foundational figures of Hesychasm into a compelling narrative of the movement's origins. The Cappadocian fathers established monasticism as the predominant milieu of Proto-Hesychasm and emphasized both *theōsis* and dark mysticism. Dark mysticism would come into conflict with the light mysticism of their contemporary Pseudo-Macarius, but both currents would be passed on to the Hesychasts. Macarius was a seminal figure within Proto-Hesychasm, responsible for its stress on light mysticism and heart mysticism. Hesychasm itself, the author contends, emerged from two main Proto-Hesychast fonts, the philosophical (represented by such figures as Pseudo-Dionysius and Maximus the Confessor) and the ascetic (the realm of figures like John Climacus and Isaac of Nineveh). The former school transmitted to Hesychasm a virtually unacknowledged Platonism; the latter contributed to Hesychasm's preoccupation with *theōsis*, *penthos*, and unceasing prayer, albeit from a solely monastic perspective. Finally, Symeon the New Theologian emerged as the redoubtable successor to these schools, unifying their distinct traditions in his philosophical approach. While previous scholarship has documented the connections between Proto-Hesychasm and Hesychasm, *Origins of Eastern Christian Mysticism* is unique in its treatment of the Proto-Hesychasts as a distinguishable group, and as direct instigators

of Hesychasm. This provocative study should be of interest to students and scholars of the late antique history of the Eastern Orthodox Church, as well as to contemporary theologians steeped in the Eastern mystical tradition.

In this landmark study of the literary relationship between the gospel of John and the synoptic gospels, Gary Greenberg presents compelling evidence for the existence of a written pre-canonical Alpha gospel that contained almost all of the main episodes in the adult life of Jesus (excluding major speeches, such as discourses, parables, and "I Am" sayings) and which became the written source for the core biography of Jesus in Mark, Luke, John, and Matthew. While Mark used the Alpha gospel with only slight variations, John had profound theological disagreements with it, objecting to its theological message about how

to obtain eternal life, the depiction of Jesus, and other matters. This induced him to rewrite the Alpha gospel so that it conformed to his own very different theological agenda. Consequently, John's gospel functions as a thorough theological critique of Mark, but the changes he introduced made it difficult to see how he and Mark worked from the same written source. By using John's theological concerns as a filter for reading and understanding what objections John would have with Mark's Jesus stories, *The Case for a Proto-Gospel* reverse-engineers the editorial path taken by John and reconstructs the content of the Alpha gospel. Finally, the author discusses the relationship of the other two synoptic gospels to the Alpha gospel, asserting that Luke also knew the Alpha gospel but used Mark as his primary source, and that while Matthew did not know the Alpha gospel, his use of Mark as a primary source ensured that his core biography of Jesus also derived from this earlier source.







Based upon recent fieldwork, six migrant Christian communities in Rotterdam were analysed using congregational study methods on how they construct identity. Through the frames of 'koinonia', 'diakonia' and 'kerygma', this research reflects on their composition, characteristics, leadership style, language and social capital. Language is found to be an important shaper or 'carrier' of identity and acts both as badge and bridge of identity. In building identity, MCCs do not behave in ways expected or consistent with the process of integration.



The relationship between Christian theology and music has been complex since the early days of the Church. In the twentieth century the secularization of Western culture has led to further complexity. The search for the soul, following Nietzsche's declaration of the Death of God has led to an increasing body of literature in many fields on spirituality. At the heart of every marriage union among the Igbo people of Nigeria is the desire to have one's own children, preferably male ones who will perpetuate the family name from generation to generation. Hence, no stone is left unturned to make sure that this aim is achieved in marriage. Oftentimes, this desire, despite every effort, is not realized by every married couple. Some marriages still remain childless. The pre-colonial Igbo were also confronted with childless marriages. But knowing the consequences of a childless marriage, they designed some methods of circumventing the problem. Almost all the methods they employed to make sure that no man died childless, which are extensively discussed in this work, are condemned by the Catholic Church. The Church proffered child adoption among other things as a solution to infertility in marriage. Child adoption, however, is frowned upon by some Igbo on the ground that it is against their culture. This situation, therefore, places some Igbo childless couples who want to remain faithful to the Christian faith on a crossroad of not knowing what to do in the face of infertility. The present work deals extensively on the meaning and ends of marriage among the Igbo people of Nigeria, on what it means to be childless among the Igbo, and on how the precolonial Igbo handled the situation as well as the importance of children in the Igbo family. The Church's teaching on marriage before and after the Second Vatican Council and especially on childless marriages as found in *Gaudium et spes* is also discussed in a very elaborate way. Other important topics discussed in this work include the Church's position on artificial reproductive technologies (ART); the meaning of child adoption; and the Igbo people's knowledge, attitude, and perception about the practice of child adoption. This work argues strongly that child adoption is something good and noble when it aims at the welfare of the child but at the same time not relegating the welfare of the adoptive parents to the background.







C'est dans une salle de classe du Grand séminaire de Luxembourg qu'a été forgée en 1993, par un groupe de travail de la Fédération biblique catholique, l'expression *animation biblique de toute la pastorale*. And how should theological training programs be transformed, so that they empower the pastoral agents to implement this pastoral vision in their Christian communities?







*An Intimate Revelation* chronicles an unprecedented multi-year research project that investigated what happens when adolescents from around the world read and discuss Jesus' Parable of the Prodigal Son together. The study gathered together adolescent participants, pastoral leaders, and theologians from several countries to read in conversational communities, and these groups then exchanged their interpretations with each other across cultural and religious distinctions. 





This book explores the relationship between the Orthodox tradition and the ecumenical practice of engagement with other Christian traditions. This relationship has for a long time been compromised by an underlying tension, as the Orthodox have chosen to participate in ecumenical encounters while – often at the same time – denouncing the ecumenical movement as deficient and illegitimate. The author perceives this relationship to be

even more inconsistent since the core of Orthodoxy as professed by the Orthodox is precisely that of re-establishing the unity and catholicity of the Church of Christ. This vision informs Orthodox identity as essentially a Church of exploration, of engagement and dialogue, a Church committed to drive all other traditions, but also itself back to the «right» primordial faith. The book exposes the risk of Orthodox theology turning into an oppositional picture of Orthodoxy as necessarily opposed to a heterodox antipode, rather than being the continuous dynamic reality of the living Church of Christ. The author proposes the rediscovery of a set of paradigms in an ethos of humble, active *metanoia* that would enable a more plenary ecumenical operation for the Orthodox as well as a renewed awareness of their own spirituality.





third way between them, but it also takes shape as a combination of philosophy and Jewish thought — a combination irreducible to each of its terms, and thus representing a *tertium datur* beyond them.

Epistemic interactivism, an aspect of the epistemology of representation, is a cognitive intercourse between the subject and person-object of knowledge that underlies the conception of a person in Esan thought. Traditional theories of representation (especially as presented by Descartes and Locke) separated the subject from the object of knowledge, and classified persons and non-persons as object of knowledge. This separation and classification ignored the cognitive and moral values of persons, disengaged the subject from the world and burdened the self with solitude and isolation, and

created propositional knowledge that dehumanised the relationship between the subject and person-object of knowledge. Within the theoretical framework of Hegel's epistemic interactivism (meliorated by Bowne's personalism) and Esan epistemology (in African philosophy), this book exposes the epistemic interactivism of Esan thought which unified the subject and person-object of knowledge on cognitive and moral grounds; thus providing an adequate basis for personhood and resolving the dehumanised relationship between the subject and person-object of knowledge in the traditional theories of representation. Within the context of epistemic injustices, this book analyses the interactivist epistemology of indigenous Esan thought as an alternative epistemological conception of the person-object of knowledge which resolves the deficiency of the traditional theories of representation.
