





The cradle of the Church of the East was in Mesopotamia (between the Tigris and the Euphrates), where it developed its first centre at Seleucia-Ctesiphon, then the capital of the great Persian Empire and today an archaeological site to the south of Baghdad. From the very beginnings of Christianity until the fourteenth century, this Church experienced a remarkable expansion in Asia, its missionaries carrying the Gospel from Persia to India, via the Persian Gulf, and even as far as China. The Church of the East reached China as early as the seventh century via Central Asia and the celebrated Silk Road that linked China to the Mediterranean world. Much later, in the late fourteenth century, the invasions of the Mongol conqueror, Timur Lang (Tamerlane), across Asia brought about a great decline of the Church of the East. Eventually, after the genocide suffered by Christians in the Ottoman Empire in 1915, and the massacres that followed in Persia, the Church of the East and its people were on the verge of extinction. In 1940 the patriarchal seat was moved to Chicago (in the United States) and then in September 2015 to Erbil (in northern Iraq). Many of the faithful have left the Middle East and have formed diaspora communities throughout the world. The history of Christianity in the Middle East and well beyond, in Central and Eastern Asia, is very little known. In this book, the reader is invited to travel in time and space and undertake the fascinating discovery of a very ancient apostolic Church, the Church of the East, whose two-thousand year history constitutes an indispensable chapter in the history of the universal Church.



This volume brings together a selection of essays from the Lecture Series in Bahá'í studies at the University of Haifa. Each chapter explores an aspect of the Bahá'í religion, including its history, community, culture and theoretical perspectives on contemporary issues. The authors discuss topics including the family and descendants of the Báb (founder of the religion from which the Bahá'í Faith emerged), the influential role of Bahá'í schools in the modernization of education in Iran, the process of introducing the law of monogamy into the Iranian Bahá'í community, early connections between Swiss citizens and Bahá'ís in the Middle East, the rich and varied landscape of Persian Bahá'í poetry, and the role of African Americans in the development of the US Bahá'í community, particularly with regard to race relations and the principle of the oneness of humanity. Also presented in this volume are Bahá'í perspectives on contemporary topics including changing conceptions of work and work values, the role of apologetics in interfaith dialogue, and the issue of 'defamation of religions' in international human rights discourse. This book examines the oracle of deliverance that Yhwh communicated to Ebed-melech, the Cushite (Jer 39,15-18). In order to comprehend this analectically presented promise, however, the research also scrutinizes two other related events in Jeremiah's mission in the context of Jer 37-39: i) the unpleasant incident in which the Jerusalem officials maliciously threw the Lord's messenger into the muddy cistern (Jer 38,1-6) and ii) Ebed-melech's benevolent intervention to rescue the prophet from the water reservoir (Jer 38,7-13). 

Animal liberation contends that humans and animals are of equal value and that standard views of human uniqueness are an anthropocentric prejudice called "speciesism." It advocates ending human use of animals in recognition of animal rights. Animal liberation theology attempts to ground similar views in the Bible. It typically envisions an original creation free of predation to be restored free of meat-eating and animal use. It views animal sacrifice as murder and speaks of a "deep incarnation" by which God in Christ takes on "all flesh" for the salvation of all creatures in a "cosmic redemption." This is the first full-fledged critique of animal liberation in general and so-called speciesism in particular from a biblical and theological standpoint, with accompanying scientific and philosophical analysis. After it introduces the major thinkers, the book demonstrates the incoherence of animal liberation with human evolution, the use of animals in the domestic and religious life of Israel, and the New Testament assertion that God the Son was uniquely incarnated in the human Jesus for human salvation. This book reasserts historic Christian faith as sufficient to the scientific, philosophical and ethical challenges posed by animal studies, and concludes with an appraisal of key ethical concerns regarding animal use and foundational issues within the animal liberation movement.





This book lists all the similes in the Bible in three different versions (Greek, Latin and English), noting especially the variation in the use of introductory words (*protheses*). There are over 1000 examples, not counting the predicate and genitive versions, a significant collection. The Introduction discusses the parts and types of similes as well as other similar figures of speech (e.g., analogies, comparisons and metaphors); examples are provided of prothetic (*prosthesis* expressed: he runs like a panther) and non-prothetic types (*prothesis* implied: he is [like] a lion in savagery). The Conclusion points out

various aspects of Biblical usage, some differing from those in classical Greek authors (Homer and Plato). The importance of similes in clarifying difficult concepts while adding grace to the narrative accounts for their popularity in philosophical and religious writers.



This book argues that Martin Luther did not enforce his own strict theological convictions about women and their nature when he personally corresponded with women throughout his daily life. This becomes clear with Luther's interactions with female family members and Reformation women. With these encounters, he did not maintain his theological attitudes and made exceptions to his own theology for such influential women. Luther also did not enforce his theology throughout his pastoral care where he treated both men and women respectfully and equally. His pastoral work

shows that he allowed his compassion and empathy to win over his own strict theological convictions about women. It is important to remember that Luther not only wrote about women in the abstract, but also lived both his public and private life among women. However, there have been no comprehensive studies that have examined his theological writings about women and personal encounters with women. For this reason, fundamental aspects of Luther have remained in the dark. As actions speak louder than words, scholars need to include the practical, as well as the theoretical when analyzing his attitudes towards women. This book not only contributes to a more nuanced understanding of Luther's theological views on women, but also how those views compare to his actual social encounters with women. This work highlights the necessity to explore Luther's personal encounters with women, as well as his theology when trying to provide an authentic assessment of the reformer's attitudes towards women.



This book elucidates the dynamism of culture and how cultural expressions are often intertwined with religious expressions. The Catholic Church, while conscious of the profound cultural diversity within her membership, earnestly seeks to inculcate the gospel message in these cultures, for a better expressed, experienced, and lived Catholicism in the modern world. The result is a book that models a partnership between theological ethics and theological interpretation that overcomes the oft-lamented gap between exegesis and ethics, with important implications for contemporary communities of faith. *Formative Feasting* will be of special interest to researchers, students, and church leaders interested in moral formation and the Bible, as well as those interested in feasting and eating in Scripture. Seminary and college courses focused on issues of food in the biblical world, as well as those exploring the relationship between exegesis and ethics, will find *Formative Feasting* an essential addition to course readings.



The social values of honor and shame, which have attracted much research from cultural anthropology and New Testament studies for the past five decades, is the main focus of the book. This book proposes the need to combine major contributions of narrative, rhetorical, and cultural anthropological approaches to trace the development of the twofold honor-shame concept throughout the Marcan narrative—with special attention to family relations. The goal of this book is to suggest that Jesus as a creative artist was heavily influenced by the Hebrew Bible's Book of Proverbs. It posits that he created some of his short parables from specific verses found in Proverbs, suggests that he expanded some basic sapient themes present in this book when composing his parables, and shows him reacting negatively to the commonly held belief that this Book's overall concept of wisdom is that the wise are rewarded and the fools are punished by God through their own self-destructive choices and subsequent actions.

Thus this text points to Jesus as an inventive artist, a concept not usually associated with him, and it complicates simplistic ways of defining biblical wisdom. Part I demonstrates how Jesus might have created his tales from specific proverbs found in the Book of Proverbs. The overarching theme for these parables is wisdom: Jesus as wisdom (1 Cor. 1:24) speaking wisdom in new ways. Part II discusses Jesus as a self-actualized artist who creatively designed these tales. It examines what shaped Jesus' artistry, what might have been the sources of his literacy, why he might have chosen to expand individual proverbs imaginatively in order to create his moral tales, and how his wisdom enhanced conventional attitudes toward wisdom as the former included and clarified his new "kingdom of God" concepts. This book could be used in courses treating Literature and the Bible, Biblical Art, The Humanity of Jesus, and Wisdom Literature Common to Christians and Jews.

How is it possible that the story about Elisha’s succession in 2 Kings 2:1-18 is now remembered as the story about Elijah’s ascent? The *intertextual* answer is provided by the contrast between the number of references about the human heavenly ascension in the Hebrew Bible, and the popularity of this theme in the Ancient Near East. However, in this dissertation we focus on the more direct *intratextual* approach. We analyze the construction of the narrative in order to discern the features of style, structure, and symbolism which emphasize Elijah’s ascent, rather than Elisha’s succession. This new book series will show that a critical understanding of religious pluralism in the past is of vital significance to debates about identity, diversity, and co-existence in the present. Studies will focus on using a historical perspective to address one of three key themes in the period between 1500 and 2000 CE: intra-religious pluralism; inter-religious pluralism; or, religion, secularism, and the nation state. Within this frame of reference, constructive contrasts between a wide range of foci, approaches, and viewpoints will be keenly encouraged.
